STATE OF THE LAKES

They "look fine to me." How are they threatened?

Our lakes are our legacy, and they are threatened. It's up to us to preserve and protect them. Water quality matters to all who live on the shores of McGrath Pond and Salmon Lake. What we do on our land affects the health of the lakes. The time has come to take action! All seven Belgrade lakes are at risk. What is the cause, you ask? It's dirt. Plain old innocent-looking dirt is the main culprit – and oh, yes, excess fertilizers and other chemicals.

Our activities, and the number of us doing them, wear down the land. Timbering. Clipping, raking and removing undergrowth to bare fragile soil. Launching boats from shore. Wake-making runs that rip up the shore and violate the 200-foot No-Wake Zone. Our activities open pathways for stormwater runoff.

Rainfall and snowmelt move dirt downhill and over the ground. Stormwater runoff cuts into the slopes. The cuts become ruts, ruts become gullies, gullies become streams. Flowing water picks up and carries natural and human-made pollutants, many of which stimulate plant growth. The pollution ends up in lakes and rivers, wetlands and ground water. Unlike flowing rivers, lakes hold their water for long times. Stormwater carries nutrient-laden soil into the lake; nutrients promote algae growth and nasty green water.

Our beautiful lakes have been hurt "by a thousand cuts." Big cuts – clearing, road runoff, and farming. Little cuts – foot traffic to and from shore, bathing in the lake. Many actions, big and small, have upset the natural balance.

Erosion is a force of nature. We cannot eliminate it. But <u>if we think about erosion</u>, <u>how stormwater behaves as it drains downhill</u>, we can do things to change its <u>impact on water quality</u>.

- Re-direct the flow of stormwater or slow it down so pollution-laden soil stays on the land
- Plant a buffer along your waterfront to slow or stop the flow of rainwater from your property into the lake.
- Stabilize the banks of your shoreline using riprap or erosion-control mulch.
- **Keep the flow clean:** Dispose of used oil, antifreeze, paints and other chemicals properly. Use detergents and household cleaners that are low in phosphorus.
- Have your septic system inspected and pumped at least every three to five years.
- Shoreland owners can find **LakeSmart tips** for maintaining ground cover and stabilizing erosion-prone areas (mainelakessociety.org/lakesmart).
- In town, keep litter and debris out of street gutters and storm drains these outlets drain directly to lake, streams, rivers and wetlands.
- Use lawn and garden chemicals sparingly and according to directions.

Lakes are retention ponds for all of our pollution, and erosion is a force of nature. If you understand that fundamental connection, you understand that <u>everyone in the</u> watershed can affect our lakes.

WATERSHED SURVEY

To Identify Sites where Nutrients Flow Into Lake

The McGrath Pond-Salmon Lake watershed was last surveyed in 1998, and despite remediation undertaken as a result of that survey, water quality – especially in Salmon

Benefits of doing a Watershed Survey

- Raises everyone's awareness of the need to protect McGrath Pond & Salmon Lake from soil erosion and other runoff problems.
- Provides landowners with information about how to eliminate runoff problems from their property.
- Documents problems currently existing in the watershed.
- Provides the means to acquire state and federal grants to protect and improve McGrath Pond & Salmon Lake water quality.
- Builds the Community by working together for the health of the lakes.
- Works toward the MISSION of the McGrath Pond-Salmon Lake Association: To preserve and protect the natural character, enhance the water quality and promote the responsible use of the lakes for the benefit of ALL.

Lake – has continued to decline. Meanwhile, efforts to treat lakes region-wide have made the health of McGrath-Salmon of great concern throughout much of the Belgrade Lakes watershed. Our proposed new survey of the McGrath Pond-Salmon Lake watershed is therefore an important step in rebuilding water-quality throughout the region.

In December the MPSLA board voted to update the watershed survey. This will serve two purposes:


- to identify sites where stormwater enters the lake (<u>external load</u>)
- to position our Association to consider an in-lake treatment to bind existing phosphorus in lake-bottom sediments (internal load).

A one-time in-lake treatment can cap the sediments already on the bottom, but we must halt erosion or the capped sediments will be covered with new sediments and the internal loading will begin again.

PLEASE SUPPORT THE SURVEY

The total cost of doing the Watershed Survey and the Watershed-Based Protection Plan based on it is approximately \$8,000. This includes fees for a lakes environmental consultant to help us organize the survey, write the report, and create a Watershed Protection Plan. She has recently managed surveys for East Pond and North Pond. Other expenses include:

- technical support (mapping, technical leaders, volunteer training, community outreach, data entry, summary report)
- mailings to watershed landowners (450 initial letters, 150 estimated follow-up letters with results & remediation suggestions).

FORTY YEARS OF WATER QUALITY MONITORING

2017 Marks 40 years of Monitoring on McGrath Pond!

In 1977, Al Souza started taking water clarity readings on McGrath Pond. Every two weeks, from May to October, he motored out to the 28-foot deep spot to take Secchi disk readings of water clarity, record sky and wind conditions. The black and white Secchi disk is lowered until it can no longer be seen through a water scope. He sent his readings to Volunteer Lake Monitoring Program (VLMP). The current VLMP monitor on McGrath is Dave Hallee, and on Salmon is John Loomis.


Formed in 1971, Maine's VLMP is the longest-standing state-wide citizen lake monitoring program in the U.S., with more than 1,200 active volunteers monitoring more than 500 lakes statewide. Many VLMP volunteers have continuously monitored the health of their lake for a quarter century, or more. The VLMP has been nationally recognized for efficiency and effectiveness in training and supporting citizen lake monitors. Much of what is known about Maine's lakes and ponds is the result of years of dedicated effort by VLMP volunteers. (from VLMP's home page)

YOUTH CONSERVATION CORPS

For Help with Erosion Control

The Conservation Corps' mission is to reduce sources of pollution in our lakes through the installation of erosion control-projects known as BMPs (best management practices). Founded in 1996, this self-sustaining summer program has completed more than 1400 BMPs on all seven lakes in the Belgrades' watershed.

Let us know if you know of an eroding site that needs stabilizing. The YCC Director is available to assess how your property may affect water quality in our lakes. Labor is provided free of charge; landowners pay for materials



and any permit fees. For YCC's free labor, the schedule for 2017 is full. BMPs will be recommended to homeowner, who can decide if theirs is a DIY project, or one for professional landscaper if a wait for YCC is unappealing.
